

- Based on our Developers team's plan and strategy, the tokens are locked in 168 smart contracts over 14 years, according to the times mentioned in the chart above.
- The PSP Project tokens will be released annually and PSP Developers tokens will be unlocked monthly over 14 years. Also, according to the PSP token distribution plan, the PSP token offering will be halved every 3 years.
- The distribution of PSP tokens is in the form of User Base so that the PSP token sales will be subject to the user's request and the PSP token offering will be subject to the number of the staked tokens according to the plan specified by the team. Furthermore, at the end of each year, all unsold or unoffered tokens will be burned and the PSP tokens from other wallets, including PSP Developers tokens and the Airdrop tokens, will be transferred to the black hole to the extent of the burnt tokens.
